Crossflatts, Monday 28 November 2016 – Employees of major local employer Computershare have been volunteering over autumn to reduce the risk of flooding and improve the habitat of local wildlife.

Six staff members at the global company's Loan Services division spent recent weekends carrying out environment work on two tributary streams adjoining the River Aire at East Riddlesden Hall.

Andrew Jones, Chief Executive Officer at Computershare Loan Services, said: "Well done to all our colleagues for their efforts to improve the environment around us and reduce the chances of flooding nearby.

"Their efforts form part of a long and proud tradition of Computershare Loan Services and our staff playing an active role in the community in Crossflatts, whether it's supporting education, raising money for charity or helping local wildlife.

The work undertaken by the volunteers also helps reduce the chances of flooding in an area that was severely affected in 2015.
