 587 new activist campaigns were launched in 2020, involving activist stakes worth \$86 billion, versus 601 campaigns in 2019 involving \$80 billion, representing a 2.3% decrease in the number of campaigns but 7% increase in value of activist stakes involved. The increase in stake value was due solely to TCI Fund Management's environmental-related proposals at eight companies where it owned stakes worth \$21 billion.

FY 2020 Global Activism Review

- The coronavirus pandemic most clearly manifested itself in the drop-off of large-cap campaigns, but small-cap activity remained strong. \$1b+ campaigns were down 15% from 226 to 192 in 2020, while <\$1b campaigns were up 5% from 375 to 395. Activism has returned to normal volume after the spring and summer Iull, and Q4 showed 8% year-on-year growth in total campaigns, and 21% growth in \$1b+ campaigns (from 52 to 63).
- There were 108 proxy fights in 2020, down 12% from 2019. Fewer fights went to a vote: 29 in 2020 vs 42 last year; and 36% of fights this year were settled, up from 26%.

Methodology

Bloomberg League Criteria

Eligible Advisers:

- All financial advisers, legal advisers, investor relations/public relations advisers and proxy solicitors that advise the company or activist on activism or major M&A-related matters during the course of an activist campaign.
- Advisers to a target company (or to board/special committee) receive company-side credit.
- Advisers to a member of the activist group or hostile/unsolicited bidder receive activist-side credit.
- Advisers to third parties do not receive credit, such as legal advisers to financial advisers and advisers to acquirers in deals where a target shareholder opposes the merger.

League Table Credit:

- An engagement will be given league table credit for a given year as long as the campaign was active within that year. Activity is defined as one or more of the following events occurring in that year:
 - Campaign began.
 - New activist objectives disclosed.
 - Contested meeting started, ended or pending.
 - Other major event occurs (i.e. settlement, lawsuit, activist letter).
 - Activist public statement (excluding withdrawing campaign).
- Only one engagement per target company per year will be counted for league table ranking purposes.
- For closed-end funds, only one engagement per ultimate parent will be counted (new in 2020, applied retroactively to 2019).
- Engagements privately submitted to Bloomberg are eligible for league table credit and are available for review on BI ACTLEAG <GO>.

General Database Criteria Included Campaigns:

- Shareholder is publicly seeking to make changes at a company without company cooperation.
- Known activist gets board seat or takes large stake at a company without disclosing public activist intentions.
- Credible news reports of above situations.
- Hedge fund or known activist files 13D after purchasing shares on the open market.
- Unsolicited bids by shareholders unaffiliated with management where bidder has toehold stake.
- All hostile bids (tender offer or proxy fight combined with bid).
- Japanese Significant Shareholder Filings/Mass Holding Reports where "Holding Purpose" field discloses activist intentions (*new in 2020, applied retroactively to 2019*).

Not Included:

- Proposals by small/ESG shareholders.
- Stakes disclosed in 13F or 13G filing without accompanying activist intentions.
- Campaigns where investor owns debt, not equity.
- Short-selling campaigns.
