Proxymity was a global award-winning innovation co-created by Citi and global custodians in collaboration with Computershare UK to provide an industry first digital end-to-end proxy voting platform that directly connects issuers with institutional investors on a real-time digital platform, for a more accurate and more transparent voting process. After being piloted in the UK recently, the solution is earmarked for roll-out in South Africa in 2020.

Institutional investors invest in a multitude of companies and market participants realised it was not possible to attend all meetings to vote. Proxymity speeds up the transmission of meeting information and voting instructions between issuers and their institutional investors. Information is exchanged instantly, as straight-through processing has been implemented throughout the complex ownership chain.
